
- 3 A total number of 1,653, 873 (one million six hundred and fifty-three thousand eight hundred and seventy-three) learners qualify for the NSNP.
- 4 As at 11 September 2020 and in accordance to the reported numbers furnished to the Department, a total number of 1,397,971 (one million three hundred and ninety-seven nine hundred and seventy-one) learners received meals in terms of the NSNP.
- 5 Two districts, namely Mokgalakwena and Waterberg Districts have outstanding statistics regarding the number of learners who receive meals in terms of the NSNP.
- 6 The Limpopo Department of Education has communicated with learners, who should receive meals from schools, and the learner transport is available for learners to receive a meal at school, or to fetch food parcels.
- 7 The total number of learners who apply for exemption, due to risk factors, not to attend schools, even for purposes of the NSNP, is in the process of being collated.
