1.2 My office is situated at 113 Biccard Street, Polokwane.


1.3 The facts deposed to herein fall within my person knowledge, save where otherwise stated, and are true and correct.

2 This is the fourth Affidavit, reporting back to the above Honourable Court in terms of paragraph 103.12 of the Order dated 17 July 2020.

3 A total number of 1,575,718 (one million five hundred and seventy-five thousand seven hundred and eighteen) learners were provided with cooked meals as at 6 October 2020. All the districts in the province submitted their reports.

- 4 Schools with high enrolment figures make use of rotation time tables for learners. If learners are not attending schools, they proceeded to collect the cooked meals at the school.
  
- 5 No special arrangement was made for learners to receive meals in terms of transport, and only learners qualifying for scholar transport in terms of the distance living from school as per the normal provincial scholar policy were catered for.
